

**Timeline for the conduct of the annual and quarterly transmission capacity booking in the entry/exit points in/out of the National Gas Transmission System for the gas year 2019-2020, in line with ANRE Order no. 167/05.09.2018, published in the Official Journal, Part I, no. 801/19.IX.2018**

<b>No.</b>	<b>Period</b>	
<b>1.</b>	<b>1 – 8 July 2019</b>	The transmission capacity applicants in the entry/exit points in/out of the national gas transmission system (NTS) send the annual capacity booking requests related to the gas year 1 October 2019 – 1 October 2020;
<b>2.</b>	<b>9 – 15 July 2019</b>	The gas transmission system operator (TSO) analyzes the annual transmission capacity booking requests sent by the applicants and notifies them on the approval or rejection of the annual transmission capacity booking request, as applicable;
<b>3.</b>	<b>5 – 12 August 2019</b>	The transmission capacity applicants in the entry/exit points in/out of the NTS send their quarterly transmission capacity booking requests related to one or more of the following quarters of the gas year 2019 – 2020, namely: quarter 1 October 2019 – 1 January 2020, quarter 1 January 2020 – 1 April 2020, quarter 1 April 2020 – 1 July 2020 and quarter 1 July 2020 – 1 October 2020;
<b>4.</b>	<b>13 – 19 August 2019</b>	The TSO analyzes the quarterly transmission capacity booking requests sent by the applicants and notifies them on the approval or rejection of the quarterly transmission capacity booking request, as applicable;
<b>5.</b>	<b>26 – 29 August 2019</b>	The TSO sends the gas transmission contracts, in two counterparts, for them to be signed, to the applicants whose annual and quarterly capacity booking requests have been approved.
<b>6.</b>	<b>30 August – 2 September 2019</b>	The applicants activate the financial guarantee in line with the conditions provided for in Article 27 point A of the Network code and send the signed transmission contracts to the TSOs in order for them to be countersigned.
<b>7.</b>	<b>4 – 11 November 2019</b>	The transmission capacity applicants in the entry/exit points in/out of the NTS send the quarterly transmission capacity booking requests for one or more of the following quarters of the gas year 2019 – 2020, namely: quarter 1 January 2020 - 1 April 2020,

		quarter 1 April 2020-1 July 2020 and quarter 1 July 2020 – 1 October 2020;
<b>8.</b>	<b>3 – 10 February 2020</b>	The transmission capacity applicants in the entry/exit points in/out of the NTS send the quarterly transmission capacity booking requests for one or more of following quarters of the gas year 2019 – 2020, namely: quarter 1 April 2020-1 July 2020 and quarter 1 July 2020 – 1 October 2020;
<b>9.</b>	<b>4 – 11 May 2020</b>	The transmission capacity applicants in the entry/exit points in/out of the NTS send the quarterly transmission capacity booking requests for the following quarter of the gas year 2019 – 2020, namely: quarter 1 July 2020 – 1 October 2020;
