1 MILLION EURO - FINANCIAL SUPPORT GRANTED BY SNTGN TRANSGAZ SA MEDIAS and its employees to the county of BOTOSANI, for household recovery after the natural disasters of 2010

Consistent with the principle of exercising a responsible management for accomplishing the mission undertaken and being aware of the importance of the financial support for an important cause, both SNTGN Transgaz SA Medias and its employees were involved and are actively involved in the life of the community supporting in solidarity the persons who suffered because of the natural disasters (floods).

In order to support the persons who suffered because of the natural disasters SNTGN Transgaz SA Medias initiated in the period July – October 2010 the humanitarian campaign **“People to People”** consisting of fundraising for these people.

Thus, **SNTGN Transgaz SA Medias** joined other national and commercial companies in the coordination of the Ministry of Economy, Commerce and Business Environment who decided to get involved financially for the recovery of the households affected by the floods.

According to the provisions of the Decision no. 11/08.09.2010 of the County Committee for Emergency Situations of the county of Botosani, SNTGN Transgaz SA Medias, company in the portfolio of the Ministry of Economy, Commerce and Business Environment, **transferred to the local public authorities in the county of Botosani the following amounts:**

- from the budget of the company: 2,150,000 lei \cong 500.000 euro;
- from the voluntary donations of Transgaz' employees 2,150,000 lei \cong 500.000 euro.
