REPORT

regarding Q III 2020 SNTGN TRANSGAZ SA procured assets, services and works having a value higher than EUR 500,000/procurement (for the procurement of assets and works) and EUR 100,000/procurement (for services)

SUMMARY

The Report contains information regarding Q III 2020 procurement of assets, services and works having a value higher than EUR 500,000/procurement (for the procurement of assets and works) and EUR 100,000/procurement (for services).

DETAILED CONTENT

There are summarized records in Annex 1 and Annex 2 of the Report regarding the procurement of assets, services and works having a value higher than EUR 500,000/procurement (for the procurement of assets and works) and EUR 100,000/procurement (for services).

The procurements are based on the 2020 Annual Programme of Sectoral Procurements (PAAS 2000), approved by Resolution no. 2/14.01.2020 of the Board of Administration, having a total value of 570,456,247.60 lei.

Following 28 (twenty-eight) updates of PAAS 2000, necessary after the revision of the execution programmes at the basis of the revenue and expense budget, the total value of the PAAS was of 800,253,745.53 lei.

The procurements presented in Annex 1 and Annex 2 of the Report were performed according to Law 99/2016 on the sectoral procurements and the Methodological norms for application approved by GR 394/2016 (as further amended and supplemented) by open tender and simplified procedures, published in the Electronic Public Procurement System (SEAP).

In Q III 2020 procurements of goods, services and works were executed **in lei** as follows:

- 4 (four) **work** procurement contracts with an aggregated value of **18,631,842.53 lei**
- 1 (one) **asset** procurement contract with a value of **21,219,900.00 lei**
- 8 (eight) **service** procurement contracts with an aggregated value of **10,083,287.80 lei**.
