

**Calendar for the National Transmission System entry/exit capacity booking process
for gas year 2023-2024, according to ANRE Order 167/05.09.2018,
published in Official Journal, Part I, No. 801/19.IX.2018**

No.	Period	
1.	3 – 10 July 2023	The National Gas Transmission System (NTS) entry/exit transmission capacity applicants send the annual transmission capacity booking requests for gas year 1 October 2023 – 1 October 2024.
2.	11 – 17 July 2023	The Transmission System Operator (TSO) analyzes the annual transmission capacity booking requests sent by the applicants and notifies them on the approval or rejection of the annual transmission capacity booking request, as the case may be.
3.	7 – 14 August 2023	The NTS entry/exit transmission capacity applicants send the quarterly transmission capacity booking requests for one quarter (Q) or several of the following quarters of gas year 2023 – 2024: Q 1 October 2023 – 1 January 2024, Q 1 January 2024 – 1 April 2024, Q 1 April 2024 – 1 July 2024 and Q 1 July 2024 – 1 October 2024.
4.	16 – 21 August 2023	The TSO analyzes the quarterly transmission capacity booking requests sent by the applicants and notifies them on the approval or rejection of the quarterly transmission capacity booking request, as the case may be.
5.	28 – 31 August 2023	The TSO sends the gas transmission contracts in two counterparts for signature to the applicants whose annual and quarterly transmission capacity booking requests were approved.
6.	1 – 4 September 2023	The applicants activate the financial guarantee compliant with the conditions established at Art. 27 (A) of the Network Code and return the signed counterparts of the transmission contracts to the TSO for signature.
7.	6 – 13 November 2023	The NTS entry/exit transmission capacity applicants send the quarterly transmission capacity booking requests for one quarter (Q) or several of the following quarters of gas year 2023 – 2024: Q 1 January 2024 – 1 April 2024, Q 1 April 2024 – 1 July 2024 and Q 1 July 2024 – 1 October 2024.

8.	5 – 12 February 2024	The NTS entry/exit transmission capacity applicants send the quarterly transmission capacity booking requests for one quarter (Q) or several of the following quarters of gas year 2023 – 2024: Q 1 April 2024 – 1 July 2024 and Q 1 July 2024 – 1 October 2024.
9.	6 – 13 May 2024	The NTS entry/exit transmission capacity applicants send the quarterly transmission capacity booking requests for the following quarter (Q) of gas year 2023 – 2024: Q 1 July 2024 – 1 October 2024.
10.	Starting with the 3rd Monday of month M – 1, within 2 working days	The NTS entry/exit transmission capacity applicants send the monthly transmission capacity booking requests for one calendar month or multiple calendar months remaining until the end of the gas year.
11.	Daily	The NTS entry/exit transmission capacity applicants send the daily transmission capacity booking requests for one gas day or multiple gas days remaining until the end of the gas year, according to the Procedure for the booking of daily transmission capacity products published on Transgaz`s website at: http://www.transgaz.ro/ro/clienti/servicii-de-transport/calendar-rezervare-capacitate
