REPORT

on the approval of the addendum to the mandate contract signed with the non-executive administrators of SNTGN Transgaz SA which includes the fixed monthly remuneration allowance and other benefits, established in accordance with the provisions of Article 39(2) of Government Emergency Ordinance No. 109/2011 on the corporate governance of public enterprises, as amended, and the empowerment of a representative of the General Secretariat of the Government to sign, on behalf of the company, the addenda to the mandate contracts of the non-executive administrators of SNTGN Transgaz S.A.

SUMMARY

Following the publication of Law No. 158 of 17 October 2025, amending EMERGENCY ORDINANCE No. 109 of 30 November 2011 on the corporate governance of public enterprises, the fixed monthly allowance of non-executive members of the board of administration may not exceed twice the average gross monthly salary for the last 12 months for the activity carried out in accordance with the main object of activity registered by the company, at class level, according to the classification of activities in the national economy, communicated by the National Institute of Statistics prior to appointment, and the total benefits granted in a year of mandate with regard to the coverage of representation, transport, and daily allowance expenses may not exceed the value of two fixed gross monthly allowances.

PROPOSAL

In accordance with the provisions of Chapter IV, Article 15, point 3, letter d) of the updated Articles of Incorporation, in conjunction with the provisions of Government Emergency Ordinance No. 109/2011 and the provisions of Law No. 158/2025, we submit the following for approval by the Ordinary General Meeting of Shareholders:

 the form of the addendum to the mandate contract concluded with the non-executive administrators of SNTGN Transgaz SA, which includes the fixed monthly allowance and other benefits established in accordance with the provisions of Article 39(2) of Government Emergency Ordinance No. 109/2011 on the corporate governance of public enterprises, as amended;

 the empowerment of a representative of the General Secretariat of the Government to sign on behalf of the company the addenda to the mandate contracts of the non-executive Administrators of SNTGN Transgaz SA.

Detailed content

In accordance with the provisions of the Mandate Contract, the Mandatary shall receive a remuneration consisting of a fixed monthly allowance.

For the duration of the application of GEO 109/2011, as amended, as in force on the date of approval of the mandate contract, the gross monthly fixed remuneration of the non-executive members of the Board of Administration cannot exceed maximum twice the average over the last 12 months of the gross average monthly salary for the activity performed according to the main object of activity registered by the company, at class level according to the classification of activities in the national economy, communicated by the National Institute of Statistics prior to the appointment. The level of remuneration is proposed by the remuneration committee of the board of administration of the public enterprise, approved by AMEPIP and approved by the general meeting of shareholders, taking into account the reference criteria in the private sector, as well as the complexity of the operations carried out by the public enterprise.

According to Article 39 of Government Emergency Ordinance No. 109/2011, as amended, paragraph 1, "The remuneration and benefits offered in accordance with the law or the mandate contract to administrators and directors within the unitary system, respectively to members of the supervisory board and members of the management board, in the case of the dualistic system, shall be recorded in the annual financial statements and in the annual report of the nomination and remuneration committee, the board of administration or the supervisory board and shall include the remuneration and other benefits granted by the company and its subsidiaries," and paragraph 2 "..... the mandate contract shall also mention other benefits, namely the coverage of representation, transportation, and daily allowance expenses, provided that the total benefits granted in a year of mandate do not exceed the value of two fixed gross monthly allowances."

The mandate contract of non-executive members stipulates in Chapter 5.1 the following rights of the Administrator in Article 5.1.7. "The Administrator is entitled to the same compensation and benefits package, including medical services and/or medical insurance, contracted by the Company for employees (if applicable)" and in Article 5.1.9. "The Administrator is entitled to reimbursement of necessary and useful expenses, incurred in a justified manner in the interest of fulfilling the mandate, based on supporting documents, but not limited to: accommodation expenses, daily allowances, transportation, fees for participation in courses, seminars, and any other types of expenses related to the performance of the mandate, regardless of whether they were incurred in connection with travel within

the country or abroad, as well as the use of inventory items/fixed assets necessary for the performance of the activity."

As a result, with the publication in the Official Journal of Law No. 158 of 17 October 2025, amending **EMERGENCY ORDINANCE No. 109 of 30 November 2011 on the corporate governance of public enterprises**, it is established that the total benefits granted in a year of mandate with regard to the coverage of representation, transportation, and daily allowance expenses shall not exceed the value of two fixed gross monthly allowances.

Thus, the mandate contracts of the non-executive members of the Board of Administration will be amended by addenda with the proposed amendments in accordance with Article 39 of GEO No. 109 of 30 November 2011 on the corporate governance of public enterprises, as amended.

In accordance with the provisions of Chapter IV, Article 15, point 3, letter d) of the updated Articles of Incorporation, in conjunction with the provisions of Government Emergency Ordinance No. 109/2011 and the provisions of Law No. 158/2025, we submit the following for approval by the Ordinary General Meeting of Shareholders:

- the form of the addendum to the mandate contract concluded with the non-executive administrators of SNTGN Transgaz SA, which includes the fixed monthly allowance and other benefits established in accordance with the provisions of Article 39(2) of Government Emergency Ordinance No. 109/2011 on the corporate governance of public enterprises, as amended;
- the empowerment of a representative of the General Secretariat of the Government to sign, on behalf of the company, the addenda to the mandate contracts of the non-executive administrators of SNTGN Transgaz S.A.

| Art. 5.1.7 The Administrator is entitled to the same package of compensation and benefits, including medical services and/or medical insurance, contracted by the Company for employees, so that the total benefits granted in one year of office do not exceed the value of two fixed gross monthly allowances. |
| Art. 5.1.9. The administrator is entitled to reimbursement of expenses related to representation, transportation, and daily allowances, provided that the total benefits granted during a one-year term (including the benefits under Article 5.1.7) do not exceed the value of two fixed gross monthly allowances. |
| Art. 11.2 The Administrator's fixed gross monthly allowance, established under the conditions provided for in Article 37(2) of Government Emergency Ordinance No. 109/2011, as amended, amounts to RON 26,946 gross per month. |
| Art. 2. Final provisions2.1. This Addendum shall enter into force at the date of its execution by the Parties.2.2. The other clauses of the Contract shall remain unchanged. |
