REPORT

regarding Q II 2019 SNTGN TRANSGAZ SA Medias procured assets, services and works having a value higher than EUR 500,000/procurement (for the procurement of assets and works) and EUR 100,000/procurement (for services)

SUMMARY

Considering Order 278/09.03.2015 of the Minister of Economy, Trade and Tourism, the Report contains information regarding Q II 2019 procurement of assets, services and works having a value higher than EUR 500,000/procurement (for the procurement of assets and works) and EUR 100,000/procurement (for services), for the publication on the Company's website within 5 days from submission at the Bucharest Stock Exchange of the Quarterly Report prepared according to the provisions of Art. 227 of Law 297/2004 on capital market, as further amended and supplemented.

DETAILED CONTENT

Considering Order 278/09.03.2015 of the Minister of Economy, Trade and Tourism, Art.1, paragraph (1), the summarized records in Annex 1 and Annex 2 of the Report regarding the procurement of assets, services and works having a value higher than EUR 500,000/procurement (for the procurement of assets and works) and EUR 100,000/procurement (for services).

The procurements are based on the annual programme of sectoral procurements approved by Resolution no. 3/31.01.2019, of the Board of Administration, namely the 2019 Annual Programme of Sectoral Procurement (PAAS 2019) in the amount of lei 2,723,171,227.46 and the Annual Programme of Sectoral Procurement for 2019 – NTS Developments in the North Eastern area of Romania with the purpose to

improve gas supply in the area and to ensure transmission capacities to the Republic of Moldova (PAAS 2019 - Moldova), in the amount of lei 890,330,194.

Following 9 (nine) updates of the P.A.A.S 2019, prepared until 30.06.2019 necessary after the revision of the execution programmes at the basis of the revenue and expense budget, the total value of P.A.A.S was of lei **lei 2,810,115,934.76**, and the amount of **PAAS 2019 – Moldova** became **lei 901,037,415.00**.

The procurements presented in Annex 1 and Annex 2 of the Report were performed according to Law 99/2016 on the sectoral procurements and the Methodological norms for application approved by GD 394/2016 (as subsequently amended and supplemented) by open tender and simplified procedures, published in the Electronic Public Procurement System (SEAP) and by negotiated procedures without prior call for competition.

In Quarter II 2019 the following procurements of assets, services and works were achieved in **lei**, as follows:

- 2 (two) procurements of Works, in the aggregated amount of lei 6,046,529.85
- 2 (two) procurements of **Assets**, in the aggregated amount of **lei** 147,089,251.00
- 3 (three) procurements of **Services**, in the aggregated amount of **lei 12,507,793.60**

At the same time, in quarter II 2019 procurements in **Euro** were achieved as follows:

- 2 (two) procurements of **Services**, in the aggregated amount of **euro 638,811.72**
