REPORT

regarding the procurement of assets, services and works with a value exceeding EUR 500,000/procurement (for the procurement of assets and works) and EUR 100,000/procurement (for the procurement of services) for Quarter II 2020 by the National Gas Transmission Company Transgaz SA (Transgaz)

SUMMARY

According to Order 278/09.03.2015 of the Minister of Economy, Trade and Tourism, the Report contains information regarding procurement of assets, services and works for Q II 2020 with a value higher than EUR 500,000/procurement (for the procurement of assets and works) and EUR 100,000/procurement (for the procurement of services), to be published on the Company's website within 5 days from submission of the Quarterly Report prepared according to the provisions of Art. 227 of Law 297/2004 on capital market, as amended, to the Bucharest Stock Exchange.

DETAILED CONTENT

According to Order 278/09.03.2015 of the Minister of Economy, Trade and Tourism, Art.1 (1), the master table is presented in Annex 1 and Annex 2 of the Report on the procurement of assets, services and works with a value higher than EUR 500,000/procurement (for the procurement of assets and works) and EUR 100,000/procurement (for services).

The procurements are based on the Annual Programme for Sectoal Procurements for 2020 (PAAS 2020) approved by Board Resolution no. 2/14.01.2020 with a total value of Lei 570,456,247.60.

Following 17 (seventeen) re-updates of PAAS 2020 necessary after the revision of the execution programmes underlying the revenue and expense budget, the total value of the PAAS amounted to Lei 734,300,273.95.

The procurements presented in Annex 1 and Annex 2 to the Report were conducted pursuant to Law 99/2016 on the sectoral procurements and the Methodological norms for application approved by GD no. 394/2016, as further amended, by open tenders and simplified procedures, published in the Electronic Public Procurement System (SEAP).

In Q II 2020 assets, services and works procurements in Lei were made as follows:

- 2 (two) **work** procurement contracts, having an aggregated value of **Lei 24,484,672.57**
- 6 (six) **asset** procurement contracts, having an aggregated value of **Lei 12**,**486**,**500**
- 12 (twelve) **service** procurement contracts, having an aggregated value of **Lei 65,568,431.42**

Moreover, in Q II 2020 procurements in Euro were concluded as follows:

- 1 (one) asset procurement, having an aggregated value of Euro 1,739,462.70

The procurements concluded in Q II 2020 are detailed in Annex 1 and Annex 2 hereto.
