

REGULATED TARIFFS FOR ACTIVITIES RELATED TO THE OPERATION OF THE NATURAL GAS TRANSMISSION SYSTEM

FOR THE PERIOD 1 OCTOBER 2025 – 30 SEPTEMBER 2026

I. The tariff for the related activity of issuing location permits for the transmission system requiring field visits

* The complexity of non-travel fees refers to the time allocated for reviewing the documentation and issuing the Approval, and may be 1, 2, or 4 hours.

** Tariffs for cases where no field work is required will apply for the issuance of the following approvals:

- issuing the Approval for works that are outside the TS safety area;
- issuing the Approval for works to be carried out at a location for which a previous Approval has been issued (still valid), under the same technical conditions as those at the time of issuing the previous Approval.

Note: In the case of documentation for the development of Regional town planning, the following will be taken into account when setting the tariff:

- If travel is required to resolve the request, a fee will be charged based on the distance traveled and the complexity of the case. Complexity (low/medium/high) is determined by taking into account the constructible area.

- If no field visit is required to resolve the request, the fee will be charged according to complexity, in which case complexity is determined by the time required to analyze the file.

II. Tariff for the related activity of the travel of a technical team to the designated location, other than as a result of a safety/security report:

If following the receipt of the technical solution and the estimated work value, the requesting person decides to continue the changing of the Transmission System facilities by deviation with other economic operators, authorized by ANRE, the requesting person has to pay to the TSO the following tariff:
