SNTGN Transgaz SA signed today the sectoral products contract for the procurement of "Compressor units – Gas turbine actuated centrifugal compressors"

On 14.06.2019 at the headquarters of Transgaz' Representative Office in Bucharest Mr. Ion Sterian, Director General of the National Gas Transmission Company TRANSGAZ SA signed on behalf of the company together with the bidder declared successful subsequent to the evaluation of the bids, namely the **Association SUTECH SRL (Leader)-SOLAR TURBINES EUROPE SA (Associate)**, the sectoral products contract no 604 on the procurement of "Compressor units – Gas turbine actuated centrifugal compressors"

The contract was signed on behalf of the Association SUTECH SRL by the director general, Mr. Gabriel Bucur and on behalf of SOLAR TURBINES EUROPE SA by Mr. WALTER JOZEF P. BERRE, Managing Director. Representatives of the company's executive management attended the event as well.

TURBINE ACTUATED CENTRIFUGAL COMPRESSORS necessary for the execution of the project "NTS Developments in the North Eastern area of Romania in order to improve gas supply in the area and to ensure transmission capacities to the Republic of Moldova" was launched onto SEAP (Electronic Platform for Public Procurement) on the website http://sicap-prod.e-licitatie.ro/pub, under participation announcement number: CN1004894/09.10.2018 and on the website of the Official Journal of the European Union dedicated to public procurements in Europe TED (Tenders Electronic Daily), http://ted.europa.eu, under participation announcement number: JO/S192 435024 of 05/10/2018. The deadline for the submission of the bids was 19.12.2018.

The price of the Contract, namely the price of the Products delivered, is **lei 139,507,161**, plus VAT, according to the legal provisions. The duration of the contract is **36 months** from the date of entry into force of the Contract and the term for the delivery of the products is **8 months** for the first **2 Compressor Units**, respectively **10 months for the following 2 Compressor Units**.

For the development of the Project "NTS Developments in the North Eastern area of Romania in order to improve gas supply in the area and to ensure transmission capacities to the Republic of Moldova" Transgaz accessed European Funds through the Ministry of European Funds - Managing Authority for Large Infrastructure Operational Program (AMPOIM) by the conclusion of the Grant Agreement no 226/22.11.2018, code SMIS 2014+ 122972.
