## 1. Available Capacities

As the result of the execution of the step-back right by Successful Bidders, the following capacities are available for booking in the third bid submission window of the Open Season Procedure.

## 2. Overview of Bidding Rules

Bidding rules are the same as they were in Bid Submission Window I, i.e.:

- bids must be submitted based on a required price/quantity relationship,
- conditionalities may be applied,
- the willingness-to-pay shall determine capacity allocation in case of oversubscription.

All parties duly registered to the Open Season Procedure may place a Bid in Bid Submission Window III, except those that have exercised the contractual step-back right and whose capacity contract was terminated consequently. Bids are expected to arrive to the TSOs from 5 February 2019, until 25 February 2019 23:59 CET, the latest.

### 3. Miscellaneous

Please note that as per Decree No. 3/2018. (VI. 1.) of MEKH, floating regulated tariffs for FGSZ were modified compared to the announcement in the Open Season Rulebook: since 1 October 2018, the regulated capacity fee for the IP Csanádpalota is:

- entry (RO>HU): 1,080.48 HUF/kWh/h/year instead of 1,483.63 HUF/kWh/h/year, and
- exit (HU>RO): 513.39 HUF/kWh/h/year instead of 631.25 HUF/kWh/h/year,
- the volumetric fee (for direction exit only): 46.37 HUF/MWh instead of 47.31 HUF/MWh, while
- the initial value of the entry supplement (RO>HU) is unchanged, i.e. 1,166.99 HUF/kWh/h/year

Please note that for Transgaz, the Reserve Prices and supplements as published in the ROHU Open Season Rulebook are applicable for this submission window.
