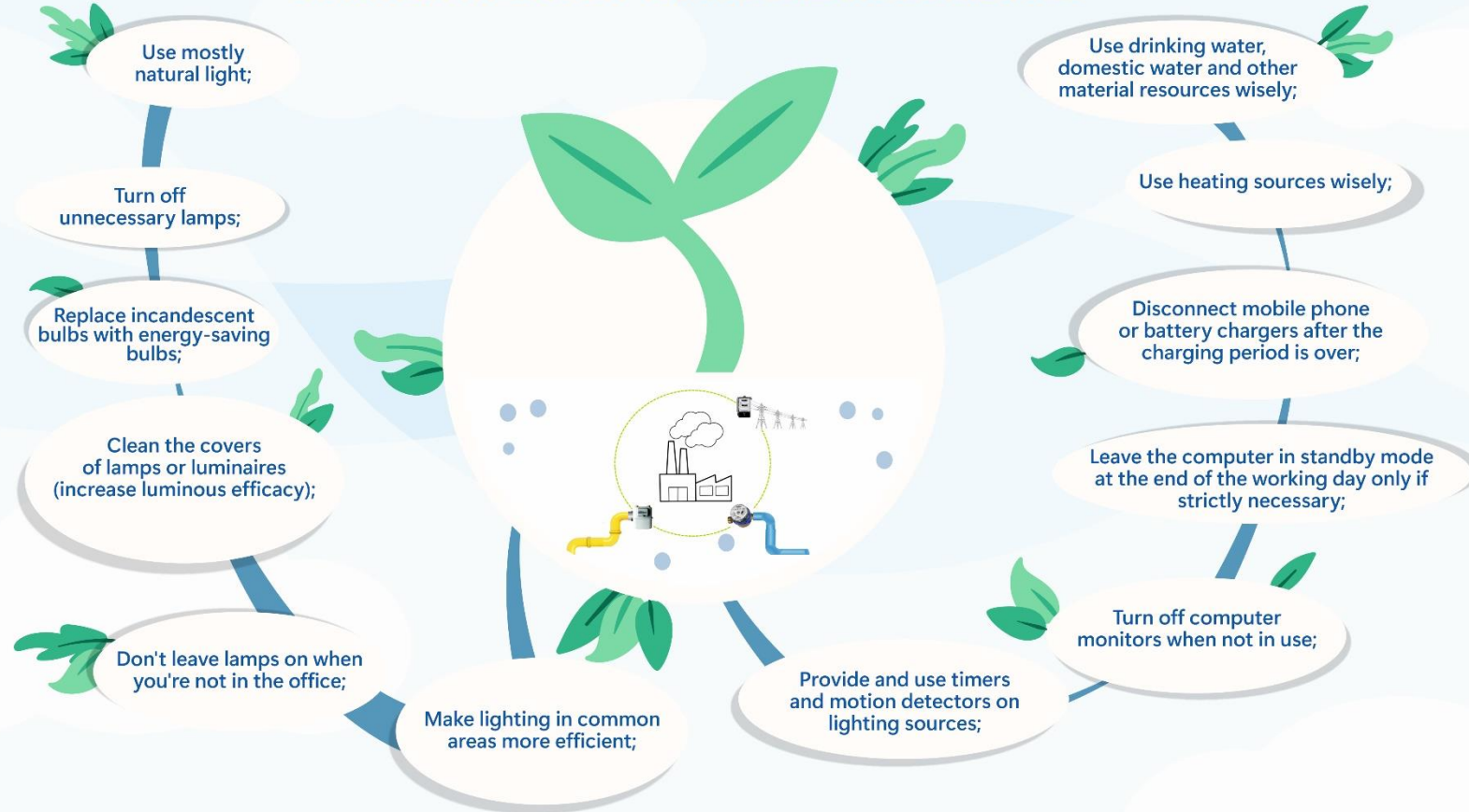


- **Use mostly natural light;**
- **Turn off unnecessary lamps;**
- **Replace incandescent bulbs with energy-saving bulbs;**
- **Clean the covers of lamps or luminaires (increase luminous efficacy);**
- **Don't leave lamps on when you're not in the office;**
- **Make lighting in common areas more efficient;**
- **Provide and use timers and motion detectors on lighting sources;**
- **Turn off computer monitors when not in use;**
- **Leave the computer in standby mode at the end of the working day only if strictly necessary;**
- **Disconnect mobile phone or battery chargers after the charging period is over;**
- **Use heating sources wisely;**
- **Use drinking water, domestic water and other material resources wisely;**
